Pursuant to Section 3 of Executive Order N-29-20, issued by Governor Newsom on March 17, 2020, the Special Meeting of the Community Services Commission for April 8, 2020 will be conducted telephonically. Please be advised that pursuant to the Executive Order, and to ensure the health and safety of the public by limiting human contact that could spread the COVID-19 virus, the Council Chamber will not be open for the meeting. Commissioners will be participating telephonically and will not be physically present in the Council Chamber.

In accordance with executive order N-25-20, guidance from the California Department of Public Health on gatherings, and in an effort to slow the spread of COVID-19 and to ensure the health and safety of our community, remote public participation can be done as follows:

Speakers must limit their comments to three minutes each, with the total time period for public comments limited to 30 minutes. Since the exact timing of a particular item is unknown, it is recommended that you call in at 6:15 p.m. to follow the meeting.
2. Email **(kalbarian@lahabracca.gov)** before or during the meeting. If an email is received prior to the close of a public comment period, it will be read by staff into the record. Lengthy public comments may be summarized in the interest of time, and will not exceed three minutes in total length per comment. Emailed public comments prior the Beautification meeting are strongly encouraged.
