La Bonita Skatepark is located at La Bonita Park and vandalism primarily occurs during the hours of darkness. In an effort to minimize vandalism the installation of a motion activated security lighting system would help deter this. The security lighting system will consist of LED lighting strategically located around the park that will be motion activated. The security lighting will be connected to the Skylogix system that allows staff to manage from mobile device.

SOURCE OF FUNDING:

The total amount of CDBG funds that are available from the Substantial Amendment approved at a Public Hearing on March 16, 2020. The Substantial Amendment that was approved, canceled FY 19-20 programs and left a balance in the amount of \$76,612.

Community Development Block Grant (CDBG) funds in the amount of \$51,000 will be allocated to the FY 20-21 La Bonita Skatepark Security Improvement Program located at La Bonita Park. The remaining balance in the amount of \$25,612 will be included as carryover funds for FY 20-21 and allocated at a later date.
