

**NOTICE OF PUBLIC HEARING OF THE CITY OF LA HABRA REGARDING
PROPOSED ADOPTION OF WATER AND SEWER SERVICE RATE ADJUSTMENTS**

NOTICE IS HEREBY GIVEN pursuant to the California Constitution Article XIID (otherwise known as "Proposition 218"), that on January 16, 2018, the City of La Habra (the "City") City Council will hold a public hearing to consider proposed changes to the water and sewer rates. The public hearing will be held on **January 16, 2018 at 6:30 p.m.**, or as soon as possible thereafter, in the **City Council Chambers, 110 E. La Habra Boulevard, La Habra, CA 90631**. The purpose of the hearing is to consider oral testimony and written protests against the proposed changes to water and sewer service charges for the parcel for which you are shown as a property owner of record.

The proposed changes are scheduled to go into effect on February 1, 2018 and January 1, 2019.

The City estimates that for a typical single-family residential customer with a 5/8" meter, using 16 hundred cubic feet (CCF) per month, their monthly water bill will increase \$0.39 per month from a current charge of \$59.32 to \$59.71 with the first revenue adjustment. The sewer charge will increase \$0.46 from the current charge of \$8.48 to \$8.94. This represents a total increase of \$0.85 per month on a combined bill basis.

PROPOSED WATER SERVICE CHARGES

The water rate adjustment is based upon increased costs for purchased water, operations, and to keep up with capital improvement bond requirements. There are two parts to the water service charges: A fixed service charge and a variable use charge. The fixed charge is based on the connection's meter size. The most common meter sizes for residential properties are 5/8" or 1". The variable use charge is determined by the amount of water served to the property and is measured in hundred cubic feet (CCF). One (1) CCF equals 748 gallons. The City bills on a monthly basis. The City also provides private fireline service to specific customers. Therefore, the City has updated the fireline service charge. Private fire service connections are typically associated with fire sprinkler systems. The fixed charge by meter size and variable charge will change as shown in the tables below.

PROPOSED SEWER SERVICE CHARGES

The sewer rate adjustment is based upon increased costs to operate and maintain the sewer system. This increase will allow the City to continue its efforts to reduce the potential for sewer spills and to comply with mandated Waste Discharge Requirements of the State Regional Water Quality Control Board. The proposed wastewater rates have a different rate structure than the current rates to increase equity amongst customer classes. The current fixed charge based on meter size has been removed and the new structure consists of monthly fixed charges per dwelling unit for residential customers and apartments, and variable charges per hundred cubic feet (ccf) of water varying for all customer classes. Commercial, municipal, and church customers are subject to a minimum charge as shown below. The fixed charge and variable charge will change as shown in tables below.

HOW DO I PROTEST THE RATE CHANGES?

If you wish to oppose the proposed rate increases, you must submit a written protest to be considered, even if you plan to attend the public hearing. If written protests are submitted by a majority of the affected property owners, the proposed rate changes will not be imposed. Your written protest must be received by the City Clerk prior to the close of the public hearing on January 16, 2018. Emailed protests will not be accepted. Written protests must contain a description of the property, such as a parcel number or address and account number. The protest must also bear the original signature of either the property owner or the water customer of record. Only one protest for each property or address will be counted. Please indicate that it is the water and/or sewer rate change that you are protesting and send or deliver your written protest to **City Clerk, La Habra City Hall, 110 E.
