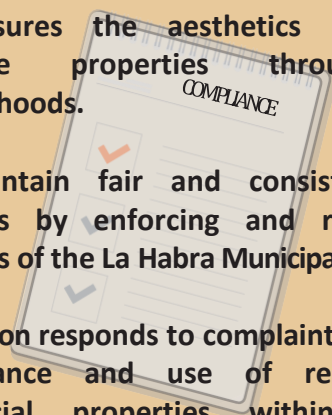

OUR MISSION:

The Code Enforcement maintains, preserves, and ensures the aesthetics and standards of the properties throughout our neighborhoods.

We maintain fair and consistent business standards by enforcing and regulating the provisions of the La Habra Municipal Code.

Our Division responds to complaints regarding the maintenance and use of residential and commercial properties within the City's approximate 7 square mile radius.



HOME OPERATED BUSINESS

In order to operate a home business, you must obtain a Home Occupation Permit through the Planning Division. All business uses must be conducted entirely within your dwelling or accessory structure. To keep your neighborhood safe and friendly, your business cannot create additional traffic, noise, odors, dust, fumes or any other public nuisance. YARD SALE REGULATIONS

- Yard Sales are allowed on the 2nd full weekend of each month (Friday-Sunday) in residential zones only. They are limited to the hours of 8:00am-5:00pm.
- No more than four (4) yard sales per calendar year.
- Signs may not be posted on telephone poles, streetlights, traffic signs or any other structures in the public right of way.
- Signs may be posted two days prior to the event and shall be removed at the termination of the sale.

OUTDOOR ADVERTISING SIGNS & STRUCTURES

Depending on the location of the business, the Sign Code determines the number and types of signs permitted. For more information, please refer to the La Habra Municipal Code, Chapter 15.40.

Prior to placement or installation of signs and/or structures, we strongly suggest you contact the Planning Division at (562) 383-4100.
